RESOLUTION NO. 18001

**A RESOLUTION OF THE BOARD OF THE VILLAGE OF SUAMICO
ORDERING AN ASSESSOR'S PLAT, IN ACCORDANCE WITH §70.27
OF THE WISCONSIN STATUTES.**

WHEREAS, Parcels SU-319-1, SU-319-3, SU-319-4, SU-319-5, SU-319-6 and that part of SU-319 lying easterly of the railroad tracks are unplatted parcels lying within the Village of Suamico, Brown County, State of Wisconsin (hereinafter "Parcels");

WHEREAS, the Village of Suamico Village Board has jurisdiction over the Parcels, in accordance with §70.27 of the Wisconsin Statutes;

WHEREAS, Village Staff has recognized that the legal descriptions of the Parcels, a copy of which are attached hereto and are fully incorporated herein at Exhibit A, are incorrect. The Parcels, as so described, contain gross errors in lot measurement and location, as set forth on the attached Exhibit B, which is fully incorporated herein;

WHEREAS, given the gross errors that exist in Parcel measurements or locations, the Village Board desires to order an Assessor's Plat, in accordance with §70.27 Wis. Stats. and this Resolution.

NOW, THEREFORE, BE IT RESOLVED, by the Board of the Village of Suamico:

Due to the gross errors in Parcel measurement and location, the Board of Trustees of the Village of Suamico hereby authorizes and orders an Assessor's Plat of the Parcels described on the attached Exhibits A and B;

BE IT FURTHER RESOLVED, that the actual and necessary costs and expenses of making the Assessor's Plat shall be paid out of the Treasury of the Village, and, further, such costs shall thereafter be charged to the Parcels in proportion that the last assessed valuation of each Parcel bears to the last assessed total valuation of all Parcels included in the Assessor's Plat. The same shall be collected as a special assessment on such Parcels, as provided by §66.0703 Wis. Stats.;

BE IT FURTHER RESOLVED, that the Village Administrator, Steven Kubacki, is authorized to retain the services of a professional land surveyor and to otherwise notify owners of record of said described Parcels and, thereafter, to certify, approve and record said Assessor's Plat, all in accordance with §70.27 of the Wisconsin State Statutes.


This Resolution shall take effect immediately from and after its passage.
