WHEREAS, the Village has an unused levy carryforward of \$493 from a county special fee in levy year 2016;

WHEREAS, the Village intends to amend SL-202M 2017 Municipal Levy Limit Worksheet to increase the adjustment for unused levy carry forward from prior years and reduce the adjustment for debt service levy for general obligation debt by an equivalent amount, thereby having zero impact on the 2017 payable 2018 allowable levy;


