

Ordinance 2016-03
An Ordinance Amending Chapter 11 Public Nuisances –Peace and Order
of the Village Code

The Village Board of The Village of Suamico, Wisconsin Does Ordain as Follows:

Ordinance Section 1: Chapter 11.42 Carrying Firearm in a Public Building of the Village code is amended to read as follows:

(1) Definitions.

(a) Firearms means a weapon that acts by force of gunpowder.

(b) Law Enforcement means any person employed by the State of Wisconsin or any political subdivision of this state, for the purpose of detecting and preventing crime and enforcing laws or ordinances and who is authorized to make arrests for violations of the laws or ordinances he or she is employed to enforce.

(c) Weapon means a handgun, electronic weapon as defined at Wis. Stats. Section 941.295, a knife other than a switchblade under Wis. Stats. Sec. 941.24, or a billy club.

(2) ~~In addition to the provisions of Wis. Stats. Sec. 175.60 enumerating places where the carrying of a weapon or a firearm is prohibited, including exceptions thereto, are hereby adopted as part of this ordinance. Any future amendments, revisions, or modifications of this statute incorporated herein are intended to be made part of this chapter.~~ it shall be unlawful for any person other than a law enforcement officer to enter the following municipal buildings while carrying a weapon or a firearm:

~~(a) Municipal Services Center, maintenance garage, wash bay, vehicle storage, salt shed.~~

~~(b) Vickery Homestead historical site, outbuildings and barn.~~

~~(c) Village Hall.~~

~~(d) Idlewild Park Shelter/building, concession stands, scorer's booths, electrical building, maintenance storage building.~~

~~(e) Old Town Office.~~

~~(f) Fire Station I.~~

~~(g) Fire Station II.~~

~~(h) Calavera Springs Park Shelter/building, storage building, scoring and storage booths.~~

~~(i) Mink Ranch Road offices, storage building/garages, central lift station, well support building.~~

~~(j) Well No. 2 Pump House.~~

~~(k) Pump House 3.~~

~~(l) Harbor Lights Reserve, Lift Station 16.~~

~~(m) Harbor Lights Lake Pump House 4.~~

(3) Signs meeting the requirements of Wis. Stats. Sec. 943.13(2)(bm) 1 shall be posted in prominent places near all entrances of such buildings regarding such restrictions.

(4) Any person who enters or remains in any aforementioned Village building contrary to such signage shall be considered a trespasser subject to penalty as proscribed under Chapter 11.101 of this code.

(5) (3) In addition to the public buildings listed at 11.42(2) above, it shall be unlawful for any person other than a law enforcement officer to enter any school property within the Village while carrying a weapon or a firearm.

Ordinance Section 2: All ordinances or parts of ordinances inconsistent with or contravening the provisions of this ordinance are hereby repealed.


Ordinance Section 3: This ordinance shall be in full force and effect following passage and publication.
