Please read the following statements and indicate you have read them by checking the box next to each item. Check Below

| 1. Fuel to be burned shall consist of dry natural wood materials, leaves, or charcoal. Materials for fires shall NOT include rubbish, garbage, trash, grass, any material made of or coated with rubber, plastic, leather, paint or petroleum based materials. | <input type="checkbox"/> |
| 2. No combustible or flammable liquids shall be permitted. | <input type="checkbox"/> |
| 3. Size of the fire shall be limited to three (3) feet in diameter no more than two (2) feet in height. Special permission for larger fires may be granted by the Fire Chief or his designee. | <input type="checkbox"/> |
| 4. The burning of wood and/or paper products in controlled receptacles (within a barrel, trash can or enclosed burner; all covered to prevent burning material or embers from escaping) will be allowed with a permit. | <input type="checkbox"/> |
| 5. No burning shall take place if the wind speeds are in excess of eight (8) miles per hour as measured at the Green Bay NOAA National Weather Service Station. | <input type="checkbox"/> |
| 6. All open fires shall be constantly attended until the fire is extinguished by an individual over the age of 16 years old. | <input type="checkbox"/> |
| 7. There shall be available for immediate utilization a means of extinguishing the open fire at all times it is burning. Acceptable extinguishing mediums include: a minimum 4-A fire extinguisher, shovel with sand or dirt available, water barrel, garden hose with water supply or water truck. | <input type="checkbox"/> |
| 8. Open burning shall take place during daylight hours only and must be extinguished at dusk. | <input type="checkbox"/> |
| 9. Minimum distance from other combustible material or structures shall be fifty (50) feet for recreational fires and one hundred (100) feet for bonfires. | <input type="checkbox"/> |
| 10. Open burning that will be offensive or objectionable to occupants of the surrounding properties due to smoke or odor emissions shall be prohibited. | <input type="checkbox"/> |
| 11. If your fire gets away, you will be liable for all expenses incurred in suppressing the fire and will be responsible for all damages caused by the fire. | <input type="checkbox"/> |
| 12. Anything that does not adhere to items 1-10 listed above shall require approval from the Fire Chief. | <input type="checkbox"/> |

Permits may be cancelled or revoked anytime at the discretion of the Fire Chief or his designee. The above statements are in accordance with 4.19 Open Burning of the Suamico Municipal Code. No permit is required for a regulated fire pit, chiminea, or portable fire place campfire.
